### Quick look...

- The budget provides GRF subsidies to 13 veterans’ organizations.
- The subsidies total \$2.8 million in each of FY 2024 and FY 2025, a 15.2% increase from FY 2023 total expenditures.

### Analysis of FY 2024-FY 2025 budget

The budget provides \$2.8 million in FY 2024 and FY 2025 in General Revenue Fund (GRF) subsidies to 13 different organizations that serve Ohio’s veterans.

The primary mission of the veterans’ organizations is to promote and assist veterans of their particular community. These groups provide services to veterans and their families to help assist with accessing benefits, job placement and training, transportation to and from Veterans Affairs (VA) medical facilities, and emergency assistance.

In addition to these state GRF subsidies, each organization may receive funding through federal grants, membership dues, fundraising efforts, and private donations. These GRF subsidies primarily are used to pay salaries and wages for service officers, transportation and meeting expenses, as well as other operating expenses. These organizations are required to annually report to the Director of Veterans Services.<sup>1</sup> The subsidy payment is not issued until the report is submitted by the organization.

The budget contains a temporary law provision requiring the Department of Veterans Services to use GRF line item 900408, Department of Veterans Services, to pay veterans’ organizations’ rent in buildings managed by the Department of Administrative Services.

The tables below summarize each of the 13 veterans’ organizations’ subsidy line items in terms of actual FY 2020 expenditures through FY 2024 and FY 2025 appropriations.
