Quick look...

- The Legislative Service Commission (LSC) is a nonpartisan agency providing drafting, fiscal, research, training, and other technical services to the General Assembly.
- LSC's governing authority consists of 14 members of the General Assembly, including the Speaker of the House of Representatives and the President of the Senate.
 - The Speaker and President each appoint six additional members, with no more than four of the appointed members from each chamber belonging to the same political party.
- The day-to-day operation of LSC is the responsibility of a director who is appointed by the governing authority. LSC staff includes budget analysts and economists within the Legislative Budget Office (LBO), attorneys and research analysts within the Office of Research and Drafting (ORD), and support personnel.
- > All funding for the proposed LSC budget comes from the General Revenue Fund (GRF).
- The LSC budget contains two appropriation items that provide funding for two additional legislative agencies: Legislative Information Systems (LIS) and the Correctional Institution Inspection Committee (CIIC).

Legislative Budget Office of the Legislative Service Commission

LSC operations are primarily funded by GRF line item 035321, Operating Expenses. The agency employs approximately 150 staff members, including budget analysts and economists within the Legislative Budget Office (LBO), attorneys and research analysts within the Office of Research and Drafting (ORD), and support staff. LSC's daily operation is the responsibility of the Director.

As the central service agency of the General Assembly, LSC provides a comprehensive array of legislative and fiscal products and services. Some of these products and services include:

- Drafting bills, amendments, and resolutions;
- Preparing bill analyses as well as fiscal notes and local impact statements;
- Providing staff for each of the standing committees and subcommittees of the General Assembly, and for various joint, select, and ad hoc committees;
- Preparing analyses of state operating and capital budgets as they move from the executive proposal to final legislative enactment, keeping track of legislative changes, and summarizing the enacted budget;
- Producing budget briefing documents such as Redbooks, Comparison Documents, appropriation spreadsheets, and Greenbooks;
- Conducting tax revenue and Medicaid expenditure forecasts;
- Performing long-term research studies and short-term research services;
- Publishing various resource documents, such as Members Briefs, Ohio Facts, Budget Footnotes, the Register of Ohio, and Digest of Enactments;
- Assisting the Controlling Board in analyzing agency spending requests;
- Drafting honorary resolutions and letters of commendation upon request;
- Providing an in-depth orientation for newly elected senators and representatives;
- Training fellows and staff for both the House of Representatives and the Senate;
- Providing technical review of the Ohio Revised Code;
- Maintaining the Ohio Administrative Code and providing technical assistance to rule filers across the state;
- Answering the toll-free hotline for legislative information; and
- Operating the legislative research library.

This line item funds a legislative fellowship program designed to provide college graduates with practical experience in the legislative process as paid full-time staff for the General Assembly, Ohio Government Telecommunications (OGT)/The Ohio Channel, or LSC. Traditionally, the program supports 24 fellows, including ten in the House, ten in the Senate, two in OGT, and two in LSC.

This line item funds the operating costs of the Correctional Institution Inspection Committee (CIIC), which is statutorily required to inspect and evaluate Ohio's prisons and authorized to inspect and evaluate state juvenile correctional facilities.

This line item pays dues for Ohio's membership in several national associations, including the National Conference of State Legislatures (NCSL) and the Council of State Governments (CSG). NCSL and CSG dues are determined by the two organizations using a population-based formula, while other organizations charge a flat annual amount. Legislative Information Services (ALI 035410)

This line item funds the operations of the Legislative Information Systems (LIS). Originally established in 1995 through a resolution of the Legislative Service Commission, LIS serves the General Assembly and legislative agencies by providing computer network services, telephone services, development of new or improved computer applications, development and maintenance of websites for the General Assembly and legislative agencies, and computer education training services. For example, LIS is responsible for the design and support of SOLAR (State of Ohio Legislative Application Repository). SOLAR entails everything from the initial drafting requests to LSC, through consideration and approval by both the House and Senate, to the preparation of an act for presentation to the Governor. It has modernized Ohio's legislation management system.

The day-to-day operation of LIS is the responsibility of the Director, who is appointed by the Commission. The LIS Director functions as the General Assembly's chief technical officer who acts to improve cooperation, standards conformity, and security in all General Assembly information technology (IT) organizations. Including the Director, LIS employs approximately 40 staff members.

Other appropriation items included in the LSC budget group

The LSC budget group contains two other "as needed" line items: GRF line items 035407, Legislative Task Force on Redistricting, and 035501, Litigation. Line item 035407 supports the operating costs of the Legislative Task Force on Redistricting, which provides assistance to the General Assembly and the Ohio Redistricting Commission in establishing Congressional and state General Assembly districts, respectively. In addition to the new appropriation proposed for line item 035407 in FY 2026, the executive budget reappropriates an amount equal to the unexpended, unencumbered portion of line item 035407 at the end of FY 2025 and FY 2026 for Task Force operations in FY 2026 and FY 2027, respectively. As of February 3, 2025, line item 035407 had an unused balance of approximately \$4.9 million.

Line item 035501 is used for any lawsuit in which the General Assembly, or either house of the General Assembly, is made a party. The executive budget also reappropriates an amount equal to the unexpended, unencumbered portion of line item 035501 at the end of FY 2025 and FY 2026 for the same purposes in FY 2026 and FY 2027, respectively. As of February 3, 2025, line item 035501 had a balance of just over \$4.9 million.
