Chartered Nonpublic Schools

A chartered nonpublic school is a private school that holds a valid charter issued by the Director of Education and Workforce. These schools are not supported by local or state tax dollars; thus, students are required to pay tuition. These schools generally are required to follow the minimum education standards for nonpublic schools and elect to seek a charter. They are eligible for administrative cost reimbursement, Auxiliary Services funding, and transportation services. A chartered nonpublic school also may enroll students who have been awarded state scholarships. Additionally, all chartered nonpublic schools are required to comply with specific laws regarding a variety of topics, including school safety plans, teacher qualifications, and, generally, high school assessments, curriculum, graduation, and diploma requirements.

Chartered nonpublic schools that accept students who have been awarded state scholarships are required to comply with additional statutes, from which other schools that do not accept scholarship students may be exempt. (The scholarship programs are the Educational Choice (EdChoice), Autism, Jon Peterson Special Needs, and Pilot Project (Cleveland) scholarship programs.)

This brief lists education laws that apply to chartered nonpublic schools.

Revised Code Reference	Description
3310.03(D), 3310.14, 3310.41, 3310.42, 3310.522, and 3313.976 (see also R.C. 3301.0711 (K) and 3313.612	Requirement to administer elementary and high school state assessments to each student enrolled in the school with a state scholarship. ⁴
3301.0711(K)	Requirement to administer the elementary state assessments to <i>all</i> students enrolled in the school (whether or not they attend with a state scholarship), if at least 65% of its total enrollment is made up of scholarship students.
3301.0711(K)(2)	Authority of a chartered nonpublic school for which at least 65% of total enrollment is made up of state scholarship students to submit a request for a waiver from administering the elementary assessments if the school meets specified conditions.
3301.163	Third Grade Reading Guarantee assessment, interventions, and retention provisions for scholarship students (applies only for students participating in the Ed Choice and Cleveland Scholarship programs).
3313.602(D)	Requirement to devote time to Veterans' Day observance (applies only to schools participating in the Cleveland Scholarship Program).
3313.603(C)(9)	Completion of one-half unit of financial literacy instruction required for chartered nonpublic high school students attending the school on a state scholarship, beginning with students in the class of 2026 (does not apply to any student who is not a state scholarship student).
3319.238 and 3319.239	Requirement that individuals have a license validation in financial literacy to provide high school instruction in that subject (does not apply to any chartered nonpublic schools that do not accept scholarship students).

The Director must consider the "particular needs, methods, and objectives" of nonpublic schools when formulating standards for them.

3313.48 and 3313.481	Standards for minimum school year and minimum school day.
3313.48(F)	Consultation with each school district that transports students to the school prior to changing the hours or days in which the school is open.
3313.482	Requirement to adopt a plan to provide instruction through a virtual education delivery model during school closure.
3313.539	Regulations for prevention of concussion and head injuries in school athletics.
3313.5310	Information and training regarding sudden cardiac arrest in school athletics.
3313.5311	Participation in extracurricular activity at district school if the chartered nonpublic school does not offer that activity.
3313.5314	Participation in interscholastic athletics cannot be denied to a chartered nonpublic school student solely due to the student participating in the College Credit Plus Program.
