## Dear Colleagues:

The Ohio Victims of Crime Compensation Fund was created to help victims of violent crime recover financial losses, and, in the past year, thousands of Ohioans have been helped through the fund.

Ohio Revised Code Section 2743.69 requires my office to prepare an annual update on the Ohio Victims of Crime Compensation Fund. This report, which covers the period from July 1, 2017, through June 30, 2018, fulfills that mandate and also details other efforts by my office to ease the burden crime victims face through no fault of their own.

Through the compensation fund, my office helps victims and their families recover certain costs incurred as a result of the crime, such as medical expenses, counseling, and lost wages. Since 1976, the compensation fund has distributed more than $\$ 372$ million to victims of violent crime in Ohio. During fiscal year 2018, my office processed 2,726 requests for compensation and paid out an average of \$2,671 per claim.

Following an increase in 2016 in the reimbursement rate for sexual assault forensic exams, the program paid for the medical expenses of 7,718 survivors of sexual assault for fiscal year 2018. This marked an increase of approximately 2,000 more sexual assault examinations than prior to the increase.

My office also awarded more than $\$ 85.5$ million in grants to over 380 community agencies across Ohio through federal Victims of Crime Act funding during the past fiscal year. While some of these grants were small in their amount, the impact on their local communities is significant.

To educate communities about available services, the Crime Victim Services staff also trained more than 3,900 people on topics that included victim compensation, elder abuse, domestic violence, sexual assault, and child abuse. Our Two Days in May Conference on Victim Assistance - one of the largest gatherings of its kind in the nation - drew more than 1,200 victim advocates and criminal justice professionals who took advantage of insightful presentations and useful workshops.

## Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred from the Court of Claims of Ohio to the Ohio Attorney General's Office on July 1, 2000. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section administers state and federal grants to support communities' victim assistance programs and provides education and training for victims, victim advocates, and the general public.

## Grants Unit

The Grants Unit of the Crime Victim Services Section administers grants from the State Victims Assistance Act (SVAA) and the federal Victims of Crime Act (VOCA), which are made up of funds from court costs and fees, not taxpayer dollars. Recipients generally include domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers, and other similar governmental and nonprofit agencies that provide direct services to crime victims.

Due to an increase in VOCA funds, every Ohio county shared in more than $\$ 85.5$ million in grants distributed to more than 380 organizations in fiscal year 2018. Some of the new programs that were funded include:

- Linking children with supports: A \$960,000 grant went to a new pilot program to assist children impacted by abuse and neglect as a result of Ohio's opioid epidemic. Kinnect began its 30 Days to Family project, which aims to prevent children from entering Ohio's already overwhelmed foster care system. When a child is removed from the home due to abuse or neglect, family specialists work to locate different possible connections for the child to live and receive services outside of the foster care system.
- Providing services in underserved communities: A grant to Gallia County Survivor Services was used to help children and other underserved populations in rural Gallia County get access to mental health treatment. Previously, no other provider in Gallia County had provided therapy or support groups free of charge, leaving a large unmet need in the community.

The Grants Unit also administers the Rape Crisis Fund, which provided more than $\$ 1$ million to rape crisis centers. The funding is used to provide direct victim services, such as crisis response, hospital advocacy, and criminal justice advocacy, to survivors of sexual assault statewide. In the current awarding period, programs are receiving $\$ 47,500$ each. The Ohio Alliance to End Sexual Violence was awarded $\$ 142,500$ to provide training and technical assistance to rape crisis centers throughout the state.

## Education and Policy Unit

The Education and Policy Unit provides training and technical assistance and also develops resources for victim services professionals. The unit also works to advance policies that secure rights and protections for victims. During fiscal year 2018, more than 3,900 individuals received some form of assistance from the unit, including in the following areas.

## Domestic violence/sexual assault

Crime Victim Services offers training and technical assistance throughout the state on domestic violence, stalking, and sexual assault issues. Communities are seeking to improve their response to victims of violent crime and are creating better policies to collaborate with allied agencies.

In fiscal year 2018, the section's DV/SA program provided trainings related to domestic violence, stalking, strangulation, elder abuse, and sexual assault investigation and prosecution.

- Sixteen trainings were conducted in 12 rural and urban regions of the state.
- About 800 multidisciplinary team members were trained by the Ohio Attorney General's Interpersonal Violence Response Training Team and national experts in Certified FETI (Forensic Experiential Trauma Interview) on the best interview methods for responding to trauma victims. Courses included information on stalking, domestic violence, sexual assault investigation and prosecution, strangulation prevention, and forensic interviewing.


## Sexual Assault Forensic Exam program

The Sexual Assault Forensic Exam (SAFE) program is statutorily mandated by Ohio Revised Code (ORC) Section 2907.28 to cover medical expenses of patients examined after a sexual assault to ensure the proper collection of physical evidence for possible prosecution. The SAFE program reimbursed medical facilities for 7,718 exams at a cost of more than $\$ 4.8$ million in fiscal year 2018.

In October 2017, the SAFE program began reimbursing hospitals that issue HIV prophylaxis to patients at risk of exposure. In collaboration with the Ohio Department of Health, a risk exposure protocol was developed for hospitals as part of the state's medical forensic exam process. Ohio Administrative Code Section 109:7-1-02(B) was enacted with an effective date of July 24, 2017, stating: "A hospital, children's advocacy center, or other emergency medical facility shall accept payment of the actual amount billed; not to exceed twenty-five hundred dollars, as payment in full for any cost incurred in administration of HIV postexposure prophylaxis protocol in rule 109:7-1-01 of the Administrative Code." The HIV program issued payments totaling \$109,032.86 in fiscal year 2018.

## Victim Information and Notification Everyday

The Victim Information and Notification Everyday (VINE) program helps crime victims and other concerned citizens gain access to information about the criminal cases and custody status of offenders. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction, the Ohio Department of Youth Services, and county jails. Individuals can register to be notified by phone, email, text, or TTY device when an offender's custody status changes. Users can register through their participating state toll-free number, VINELink mobile app, VINE MobilePatrol app, or VINElink.com.

Below are fiscal year 2018 VINE statistics:

- On average, 127,643 online searches were conducted each month at www.vinelink.com, the primary registration point for Ohio.
- On average, 6,680 new registrations were logged each month.
- VINELink usage increased 11.3 percent over comparable 12-month periods, from 871,308 to 969,496.
- New registrations increased 16.0 percent, from 69,084 to 80,159.
- Phone notifications decreased 22.6 percent, from 348,719 to 270,059.
- E-mail notifications increased 0.9 percent, from 95,782 to 96,677.
- SMS Text Messaging Notification totaled 42,763 events in the first full fiscal year of operation.


## Child victim trial preparation training

Fifty-five law enforcement officers, prosecutors, forensic interviewers, and child protection professionals were trained to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals the necessary skills to conduct competent investigative interviews of child abuse victims.

## Support and Outreach Services

The Support and Outreach Services Unit provides direct victim advocacy and educates communities about available crime victim services. The unit coordinates training, special events, and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing education credits.

The unit organized the 27th annual Two Days in May Conference on Victim Assistance, which was held May 14-15, 2018, in Columbus. The annual event is one of the nation's largest conferences on victim assistance. More than 1,200 people attended the 2018 conference, which has a theme of "Protecting Ohio's Families." The conference included featured speakers and 35 workshops to address issues and advocacy training.

In addition, 49 victim advocates and criminal justice professionals were trained through the five-day Basic Advocacy Skills in Crime Victim Services (BASICS) Academy in fiscal year 2018.

After making initial contact with a victim of crime, the law enforcement agency responsible for investigating the crime must promptly provide the victim in writing an explanation of his or her rights, often in the form of the Ohio Crime Victim Rights Booklet, which is produced by the unit. In 2018, the section distributed 70,000 booklets to 360 agencies.

The Attorney General's Office also released a "You Have Rights" card for law enforcement to distribute to victims of crime. The card offers information about victims' rights under the Ohio Crime Victim's Bill of Rights or Marcy's Law. The office distributed 110,000 of the cards in fiscal year 2018.

## Crime Victim Compensation Program

Chapter 2743 of the Ohio Revised Code governs the compensation program, which allows applicants to be reimbursed up to $\$ 50,000$ for economic losses they incur as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses.
- Funeral and burial expenses (up to $\$ 7,500$ ).
- Dependents' economic losses resulting from the death of a victim.
- Counseling expenses for immediate family members of victims of domestic violence, sexual assault, homicide, or a crime that has resulted in a severe and permanent incapacitating injury, such as paraplegia (up to $\$ 2,500$ per family member).
- Crime scene cleanup expenses (up to $\$ 750$ ).
- Compensation for property held as evidence (up to \$750).

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payer of last resort and will not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must not have engaged in any conduct that substantially contributed to the injuries sustained.
- Must not have engaged in violent felonious conduct or drug trafficking within 10 years of the incident for which the claim has been filed with this office.
- Must not have any felony convictions, domestic violence convictions, or child endangering convictions within 10 years of the incident for which the claim has been filed with this office.


## Administrative Costs

Administrative costs for fiscal year 2018 totaled $\$ 6,234,069$. The number of appeals to the Court of Claims increased from 44 to 51.

The Attorney General's costs increased 12.2 percent, from $\$ 5,554,942$ to $\$ 6,234,069$. Because this involved 5,013 claims, the Attorney General's cost per claim averaged \$1,243.

## Application and Award Summary

The Compensation Unit processed 5,013 compensation claims in fiscal year 2018. The average award for claims totaled $\$ 2,671$, up from $\$ 2,406$ the year before. The total amount paid to crime victims throughout the state was $\$ 7,282,291$ in fiscal year 2018. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available.

The fund's balance has remained relatively stable in recent years, as illustrated in the chart below. Fiscal year 2018 saw a decrease in the fund total of 26.7 percent.


## Attorney Fees

Two types of attorney fees are payable under the crime victim compensation statute.
Under ORC 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The $\$ 120,710$ in attorney fees paid out in fiscal year 2018 represents a 2.7 percent decrease from the previous year.

Under ORC 2743.51(F)(4), attorneys who assist the claimant with successfully obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding $\$ 1,000$, at a rate not exceeding $\$ 100$ per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding $\$ 30$ per hour. The total amount paid to attorneys assisting with protection orders increased 6.1 percent in fiscal year 2018, from $\$ 403,816$ to \$428,278.

## Awards by Incident Type

As in past years, the majority of the awards paid went to victims of assault (44.6 percent). Next were awards related to incidents of sexual assault ( 14.1 percent) and domestic violence ( 13.3 percent).

## Subrogation

The Attorney General holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies, and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, which included returning $\$ 305,402$ to the fund in fiscal year 2018, a 5.3 percent decrease over the year before.
