Dear Colleagues,

By any measure, Ohio's concealed-carry licensing system has succeeded in combining safeguards that protect the public and provisions that uphold Americans' right to bear arms and protect themselves.

County sheriffs, the backbone of the program, deserve credit for its success. In 2020, they issued 169,232 licenses, up 27.8% from the year before. They also rejected 1,777 applicants who failed to meet state-mandated requirements and revoked 429 licenses for causes including felony convictions and mental incompetence, as required by law.

This report, per Ohio Revised Code Section 109.731(C), delves into 2020 data supplied by the Ohio Peace Officer Training Commission, a division of my office. Among the statistical highlights:

- The number of new licenses issued hit 96,892, the third-highest in the 16-year-old program. Eighty-five of Ohio's 88 county sheriffs issued more licenses last year than they did in 2019.
- The number of licenses renewed was 72,340, also the third highest ever.
- Roughly 700,000 Ohioans held active licenses, making the number of licenses suspended (1,618) and revoked (a combined 2,047) comparatively miniscule.

To ensure that the program runs as designed, my office partnered with the Ohio Department of Public Safety last year to forge a new path, and we now alert sheriffs when a court deems a license holder to be mentally incompetent. This means that a population not legally permitted to own a gun can no longer escape notice.

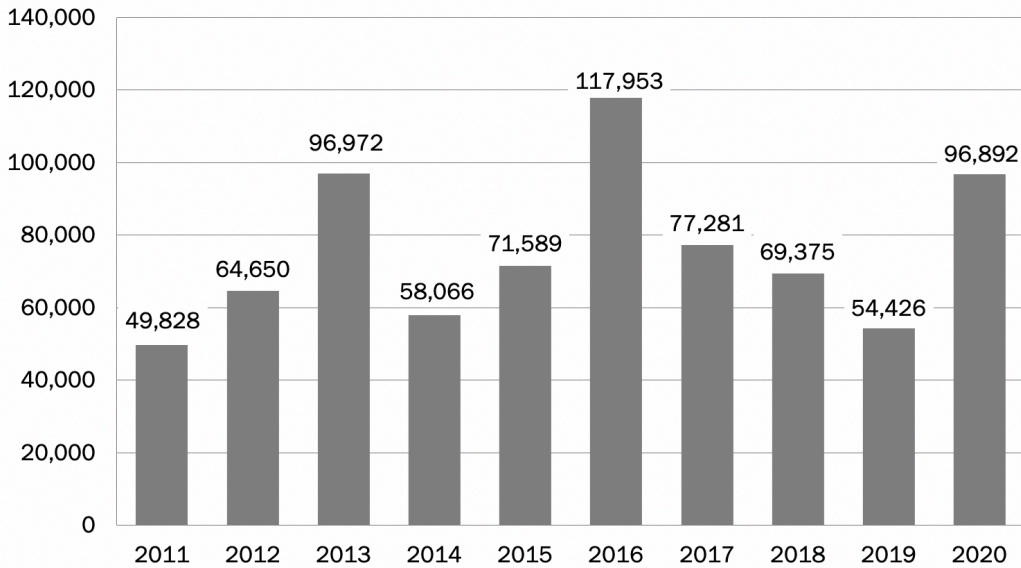

New Licenses Issued

In 2020, sheriffs in the Buckeye State issued the most new regular licenses since 2016 and a 78% increase over 2019.

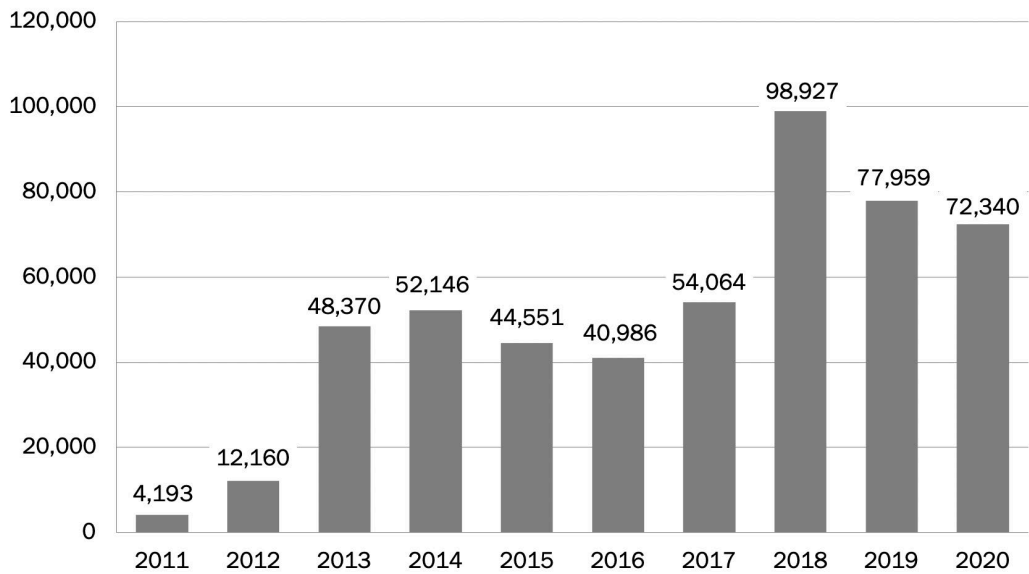

Residents of Ohio can apply for a concealed-carry license in their home county or a county sharing a border with their home county, according to ORC 2923.125(A).

Licenses Renewed

The number of licenses renewed in 2020 dropped slightly from the year before, but it was still the third-highest annual total in the program's history.



The first renewal period under Ohio's concealed-carry law was 2008, for permits issued in 2004, the inaugural year of the program. Because of a subsequent change to the law, permit holders seeking to keep active licenses now must renew every five years. In total, licenses have been renewed 567,202 times.

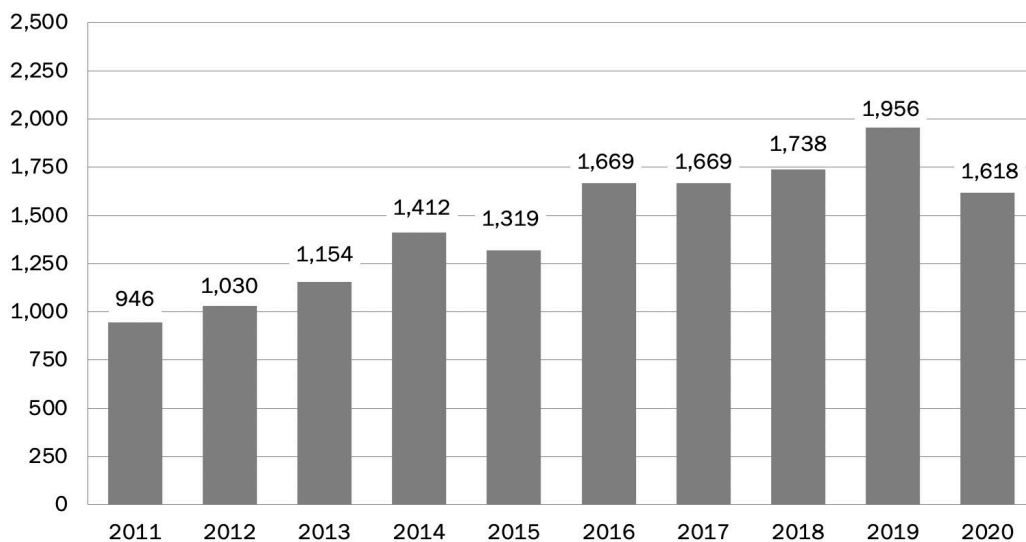

Licenses Suspended

The number of license suspensions was the lowest since 2015.



Under Ohio Revised Code Section 2923.128, sheriffs must suspend a concealed-handgun license upon learning that the holder has been arrested or charged with certain offenses, or if the licensee is the subject of a protection order. If the holder is found not guilty or charges are dismissed, the license may be returned.

The licenses suspended last year may have been issued in 2020 or a previous year. Sheriffs are not required to report a reason for a license suspension.

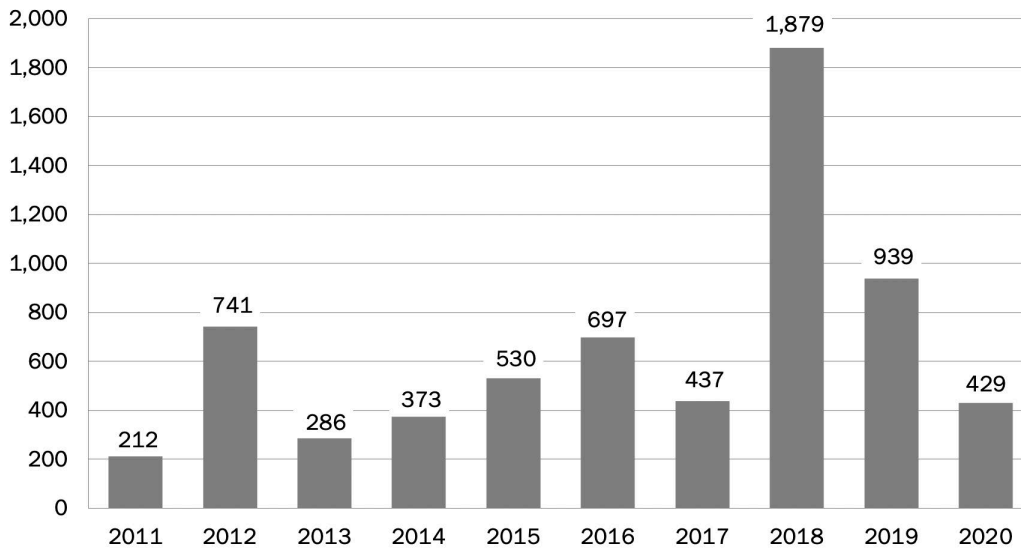

Licenses Revoked

The number of licenses revoked in 2020 was the lowest since 2014.



Under ORC 2923.128, sheriffs must permanently revoke the license of any person who no longer meets the eligibility requirements to carry a concealed handgun. A license may be revoked when the holder moves out of state, dies, cancels the license, is convicted of a disqualifying crime, or becomes subject to the law's restrictions on mental illness or drug or alcohol dependency. Sheriffs are not required to report the reason for a revocation.

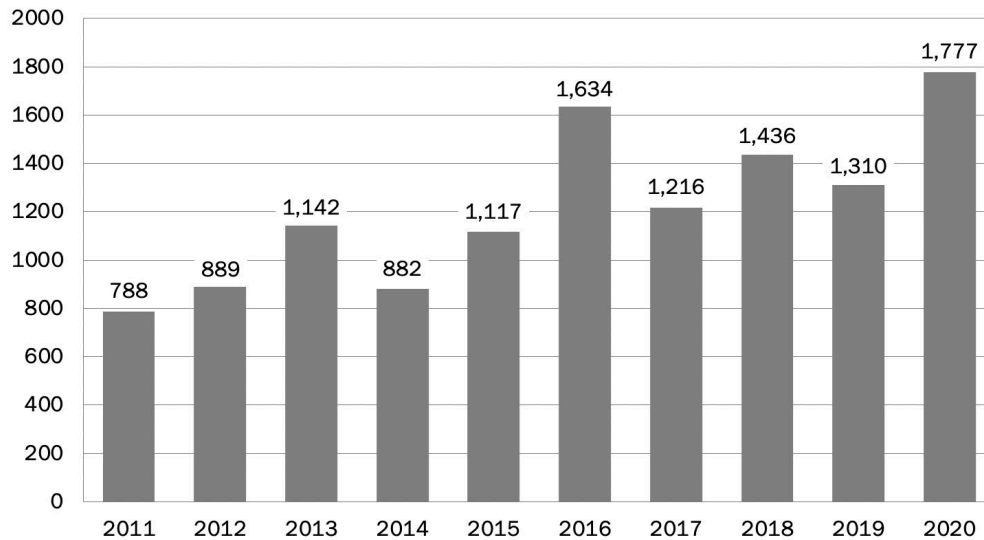

Applications Denied

The number of regular-license denials was the highest in the program's history. Still, of all regular-license decisions made in 2020, denials amounted to 1%.



The law requires that sheriffs deny an application to any person who fails to meet the eligibility criteria specified in ORC 2923.125 for regular licenses or ORC 2923.1213 for temporary emergency licenses.

Reciprocity Agreements

Ohio law requires the attorney general to craft reciprocity agreements with other states to allow people with Ohio permits to carry weapons in those jurisdictions and for those states' residents to carry handguns in Ohio.

Ohio automatically recognizes the concealed-handgun licenses of other states, but reciprocity agreements require an analysis of the other states' laws to ensure that they meet Ohio's requirements (ORC 109.69) and vice versa. Ohio permit holders can carry concealed handguns in these 36 states:

New Safeguard

In Ohio, individuals declared mentally incompetent are barred from owning guns and from having a concealed-carry license (ORC Sections 2923.13 and 2923.128). In a special examination of the system in 2020, the Attorney General's Office discovered that this disqualification could fall through the cracks.

When courts declare Ohioans mentally incompetent, they notify the Attorney General's Bureau of Criminal Investigation (BCI). As a result, background checks can find the disqualification and prevent the person from obtaining a license. But if a person who already had a license was ruled incompetent, there was no process to trigger a revocation. That is because the Ohio Department of Public Safety (ODPS) maintains the list of concealed-carry license holders, and BCI had no access.

The analysis found 41 people in 17 counties who should not have had licenses. That is a tiny fraction of the estimated 700,000 license holders. In 35 of the cases, the person was ruled mentally incompetent after obtaining a concealed-carry license.

To solve the problem, Attorney General Yost forged a memorandum of understanding with ODPS that results in regular cross-checks. County sheriffs are now notified by BCI when action is required.
